#### Dear St. Vincent Ferrer Parishioners:

I am pleased to provide you (on the back of this letter) with our Annual Parish Report for the fiscal year that ended June 30, 2008, with a comparison to the results from 2007. As you can see, we face a number of financial challenges here at St. Vincent Ferrer Parish.

The cost to keep our parish operating as a healthy and vibrant Catholic faith community continues to increase. Whenever possible, we have controlled our costs. For example, we moved daily Mass from the church to the chapel, and placed controls on the use of air conditioning. In 2006, we even took the painful action of reducing staff. You can see these measures reflected in the Report, in that total expenses dropped by over \$17,000 from 2007 to 2008. In the two-year period from July 2006 to July 2008, we reduced total parish expenses by almost \$30,000. I thank everyone who participated in these cost-cutting efforts.

Total income in 2007-2008 was almost the same as the year before. Because income has not increased, we continue to operate at a deficit. This year, expenses exceeded income by just over \$96,000. In 2006-2007, the deficit was well over \$100,000, and we had to take \$85,000 out of savings to meet expenses. We will have to reduce savings again in 2008. I pray for a renewed Stewardship spirit at our parish to increase involvement and income.

The results of our "Door Campaign" to reduce our parish debt illustrate the generosity of St. Vincent Ferrer parishioners. Nearly 100 parish families donated \$322,894 to reduce our parish debt in 2007-2008. That is an average gift of over \$3,200 each. However, Sunday collections in 2007-2008 dropped by \$17,000 from the previous year. I ask every family to do what they can to remedy this in 2008 and 2009. It is vitally important that our Sunday collection remain strong. Your Sunday gifts are the mainstay of our parish income, so please consider increasing your donations. Even better, call the parish office to make your donations by Pledge Connect – no checks to write, and it helps our parish.

I am grateful to everyone who has made St. Vincent Ferrer Parish a wonderful place to worship and grow in our faith. My God bless us with His love and grace as we look to the future together.
