Dear St. Vincent Ferrer Parishioners:

I am pleased to provide you (on the back of this letter) with our Annual Parish Report for the fiscal year that ended June 30, 2009, with a comparison to the results from 2008. Although we significantly reduced our deficit spending in 2009, we still face a number of financial challenges here at St. Vincent Ferrer Parish.

Many parish families have responded to our "Door Campaign" to reduce the parish debt. We raised over \$300,000 in 2008, which allowed us to create a fund to pay off our debt over 20 years with regular monthly payments of \$9,062. Contributions in 2009 for debt reduction are being used for this same purpose. Thank you to everyone who made this possible.

The cost to keep our parish operating as a healthy and vibrant Catholic faith community continues to increase, despite all cost cutting efforts. This year we incurred substantial extra repair expenses, and the cost of health insurance for our employees increased by 5%. Combined these cost the parish over \$87,000.

Parishioners who made extra capital improvement contributions, a successful year of bingo, a tuition increase at the school, and a bequest helped sustain income in 2009. However, I regret that our Sunday collections continue to decline, and our festival income dropped significantly. Because of our efforts to focus on increasing parish income, the deficit in 2009 was only \$7,754. In 2008 our deficit was \$96,122, and in 2007 the deficit was \$113,174.

Our parish continues to spend more than we collect. It is vitally important that our Sunday collection remain strong. Your Sunday collection gifts are the mainstay of our parish income, so please consider increasing your donations. Even better, call the parish office to make your donations by Pledge Connect. Today, parish families make over \$10,000 in donations to our parish every month using Pledge Connect. Please consider joining them.

I am grateful to everyone who has made St. Vincent Ferrer Parish a wonderful place to worship and grow in our faith. My God bless us with His love and grace as we look to the future together.
