Dear St. Vincent Ferrer Parishioners:

I am pleased to provide you (on the back of this letter) with our Annual Parish Report for the fiscal year that ended June 30, 2010, with a comparison to the results from 2009. Thanks in part to a generous bequest from Marie Bergmann's estate and Bingo results, our income exceeded our expenses for the first time in many years. The extra income will help us meet some financial challenges here at St. Vincent Ferrer Parish.

You already know we are replacing the church air conditioner at a cost of almost \$67,000. Looking ahead, we will have to replace two aging boilers, repair our roofs, resurface the parking lot and replace the parish truck. The savings we are able to set aside this year will help fund these expenses.

Although we finished the year with positive income, we are still catching up from previous deficit years. From 2007 through 2009, the deficit exceeded \$217,000. We still rely on the generosity of our parishioners for the daily operation of our parish and for major repairs. This month, all your donations using the gray **Capital Improvement – Special Offering** envelope will help pay for the new church air conditioner.

At June 30 our parish debt was \$1,120,899. Every month we make a \$9,500 payment of principal and interest toward our parish debt. Our income now allows us to reduce the principal by an extra \$770 each month, enabling us to pay off our debt in 16 years.

I regret that our Sunday collection continues to decline, and our festival income has been affected by the economy. **Your Sunday collection gifts are the mainstay of our parish income.** It is vitally important that our Sunday collection remain strong, so please consider increasing your donations. Even better, call the parish office to make your donations by Pledge Connect. Today, parish families make over \$11,000 in donations to our parish every month using Pledge Connect. Please consider joining them.

I am grateful to everyone who has made St. Vincent Ferrer Parish a wonderful place to worship and grow in our faith. May God bless us with His love and grace as we look to the future together.
